
CLARIFICATION ON GROSS RENTAL INCOME IN THE ANNUAL REPORT 2010

We refer to an enquiry raised at Cambridge Industrial Trust's ("CIT") Annual General Meeting held on 27 April 2011 regarding the FY2010 gross rental income of 30 Toh Guan Road and 55 Ubi Avenue 3. The gross rental income noted on pages 26 and 31 of the Annual Report 2010 reflect the gross rental income earned for these properties, since they became multi-tenanted in December 2010 and September 2010 respectively.

For clarity, the following table illustrates the annual gross rental income earned for FY2010 compared with the reported amounts.
