# **COMPLETION OF DIVESTMENT OF 63 HILLVIEW AVENUE FOR \$\$140.8 MILLION**

Further to its announcement dated 5 July 2013, Cambridge Industrial Trust Management Limited, as manager of Cambridge Industrial Trust ("CIT"), is pleased to announce that the divestment of CIT's entire stake in 63 Hillview Avenue was completed on Friday, 27 September 2013.

The Sale Consideration of S\$140.8 million represents a premium of approximately 28% above the current book value of CIT's entire stake in the Property of S\$110.0 million.
