ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

Cambridge Industrial Trust Management Limited, as manager of Cambridge Industrial Trust ("CIT" and the manager, the "Manager") wishes to announce that the Manager has today issued 6,007,201 units in CIT at an issue price of S\$0.6072 per unit pursuant to CIT's Distribution Reinvestment Plan ("New Units") in respect of the distribution of 1.204 cents per unit for the period from 1 July 2015 to 30 September 2015 (the "3Q2015 Distribution").

The New Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (the "SGX-ST") at 9.00am on 8 December 2015.

The New Units will rank pari passu in all respects with the existing units in CIT ("Units").

Following the issue of the New Units, the number of issued Units will increase from 1,291,767,986 to 1,297,775,187.

Eligible unitholders of CIT ("Unitholders") who did not elect to participate in the Distribution Reinvestment Plan and overseas Unitholders who did not provide registered addresses in Singapore to CDP will receive all of their entitlements to the 3Q2015 Distribution in cash on 8 December 2015.
