INTENTION OF RBC INVESTOR SERVICES TRUST SINGAPORE LIMITED TO RETIRE AS TRUSTEE OF ESR-REIT

ESR Funds Management (S) Limited, as the manager of ESR-REIT (the "Manager") wishes to announce that the Manager has been informed by RBC Investor Services Trust Singapore Limited of its intention to retire as trustee of ESR-REIT (the "Trustee", and such communication of intention to retire as the "Communication"). The Manager understands from RBC Investor Services Trust Singapore Limited that it intends to cease provision of trustee services for all authorised collective investment schemes in Singapore.

For the avoidance of doubt, the Communication is not to be taken as the Trustee's notice of retirement pursuant to Clause 23.2 of the Deed of Trust originally dated 31 March 2006 (as may be amended, supplemented, restated or varied from time to time, collectively, the "**Deed of Trust**"). The Trustee will give the requisite notice of retirement in writing to the Manager in accordance with the provisions of the Deed of Trust at a later time in the future, upon which the Manager will make announcement of such notice of retirement and the proposed incoming trustee.

Notwithstanding the above, the Trustee will continue to carry out its duties in accordance with the Deed of Trust until the effective date of its retirement and appointment of the incoming trustee. The Manager is currently in the process of appointing an incoming trustee and will work together with the Trustee and the incoming trustee to ensure a smooth transition for this change of trustee.
