The issue price of S\$0.4024 per DRP Unit represents a discount of 2.0% to the volume-weighted average traded price per ESR-LOGOS REIT unit for all trades done on the Singapore Exchange Securities Trading Limited from 3 August 2022 to 4 August 2022 (both dates inclusive).
