**ESR-LOGOS REIT DIVESTS 70 SELETAR AEROSPACE VIEW  
AT 4.8% PREMIUM TO VALUATION<sup>1</sup>**

ESR-LOGOS Funds Management (S) Limited, the manager of ESR-LOGOS REIT (the “**Manager**”), is pleased to announce that Perpetual (Asia) Limited, in its capacity as trustee of ESR-LOGOS REIT (“**E-LOG**”), has entered into a contract of sale to divest 70 Seletar Aerospace View, Singapore (the “**Property**”) (the “**Divestment**”) for approximately S\$7.1 million (excluding divestment costs and applicable goods and services tax) (the “**Sale Consideration**”).

The Divestment is not expected to have a material impact on E-LOG’s net asset value and distribution per unit for the financial year ending 31 December 2022. The net proceeds from the Divestment will be deployed to repay outstanding borrowings and/or fund general working capital requirements.

Upon completion of the Divestment, E-LOG’s diversified portfolio will consist of 81 properties (excluding 48 Pandan Road held through a joint venture) located across Singapore, Japan and Australia, as well as investments in three property funds in Australia. The Divestment is expected to be completed in 2Q2023 and is subject to JTC Corporation’s approval.

**About the Property**

Located in Singapore’s Seletar Aerospace Park, 70 Seletar Aerospace View is an aerospace training facility with gross floor area of 4,992 sqm. The Property is approximately 8 years old and has a remaining land lease tenure of about 19 years<sup>2</sup>.
